Thanks to them, key European texts by such figures as Alfred Jarry, Raymond Queneau, Anatol Stern and Pol-Dives were made accessible to English-speaking audiences.

But given the complex and often multilingual cultural heritage of these writers – whose influences included German, Russian, and Ottoman – their contribution to French literature represents a unique hybrid form of francophonie. Focusing on the historical, cultural, and artistic links between France and Romania in the twentieth century from the standpoint of such figures as Tristan Tzara, Anna de Noailles, Panait Istrati, Eugène Ionesco, Isidore Isou, and E.M. Écrire la guerre, écrire le conflit

Lille 3, Maison de la Recherche (bât.F)

16-17 novembre 2012

Écrire la guerre se réduit-il à écrire sur la guerre ? A faire du conflit ou de la lutte armée une thématique privilégiée ? Écrire la guerre, n'est-ce pas se demander quelle part l'écriture elle-même prend au *polemos* antique ? C'est-à-dire au conflit fondamental qui semble constitutif de la nature (humaine) elle-même et de l'Histoire. On cherchera surtout à explorer les aspects esthétiques, voire philosophiques et historiographiques d'une problématique qui, issue de la pensée métaphysique, se laisse également formuler en des termes transhistoriques. There are five topics: 1) 'Arabic sources in black and white: a study of Arab authorities in the Latin encyclopaedias of the 13thc.'; 2) 'Between the East and the West: the sources and scopes of the Byzantine Suda (10thc.); 3) 'From the Speculum historiale to the Miroir historial: towards a more 'neutral' approach of Islam'; 4) 'A comparison of the Oriental

and Occidental traditions with respect to the Wonders of the Word'; and 5) 'From Latin to the vernacular: the translation of Arab authors into the Romance-speaking area'.

The three fellowships for doctoral research (Topics 1 to 3) are for a 45-month tenure. Topics 1 and 3 are to start in October 2012. Topic 2 will begin in October 2013. The net monthly allowance for PhD students would amount to c.1,500-1,700 euros. Applicants for these fellowships should not be over 30 years of age at the time of application.

Topic 5 is normally to begin by October 2012, and Topic 4 by October 2013, although some flexibility with the dates is possible. The net monthly allowance for post-doc fellows would amount to 2,000-2,300 euros. Applicants for post-doctoral fellowships should not be over 38 years of age at the time of application. They should not have stayed or worked in Belgium for more than 24 months during the three years that precede the appointment. They should not have obtained their PhDs more than 6 years prior to this appointment.
